

Local SEO used to be fairly mechanical. Claim the listing, clean up the citations, add a few city pages, collect reviews, and wait. That playbook still matters, but it no longer explains why one nearby business gets surfaced across maps, local packs, voice results, AI generated summaries, and branded queries while another business with a similar location and service list barely appears.

The difference increasingly comes down to how well a business is understood as an entity, not just how well it ranks for a string of keywords.

That shift has created room for a new specialist: the AI search visibility consultant. The title sounds modern, but the work is grounded in something practical. This is where traditional SEO workflows can break down. A business may have optimized title tags and a well-built site, yet still struggle because its digital footprint sends mixed signals. I have seen businesses rank poorly not because they lacked content, but because their business categories were misaligned, their practitioner pages confused entity relationships, their review themes did not match their target services, and major directories still carried an old phone number from a relocation two years earlier.

Modern local SEO is no longer just about adding more content. It is about making the business easier for machines to verify.

## **The consultant's actual job**
