

What the anion gap shows

The **anion gap** is a practical way to understand **acid-base balance** using standard **electrolytes** from a blood test. It compares the major measured cations and anions, especially **sodium**, **chloride**, and **bicarbonate**. In basic terms, the result helps suggest whether there are surplus **unmeasured anions** or other shifts in the body's chemistry that point toward a particular **acid-base disorder**.

Clinicians often use the anion gap as a **screening tool**, not a final diagnosis. Error 1: Skipping correction for albumin

This happens because albumin acts as a major unmeasured anion, so low levels decrease the baseline gap.

Instead, it should lead you to consider whether the corrected value suggests a **metabolic acidosis** or other abnormality.

A further concern is that albumin-related changes can be mistaken for a reassuring result when total protein is not considered. **Total protein** does not replace albumin correction, but it can add context about the patient's broader nutritional, hepatic, or inflammatory state. The main lesson is that a "normal" anion gap in the setting of hypoalbuminemia is not always truly normal.

Issue 2: Ignoring inter-lab variation

Not all lab shows the identical **reference range** for the anion gap. Differences in **assay method**, sample processing, and instrument calibration can alter the result. This is why **laboratory variation** so important: a number that looks abnormal in one system may be normal in another.

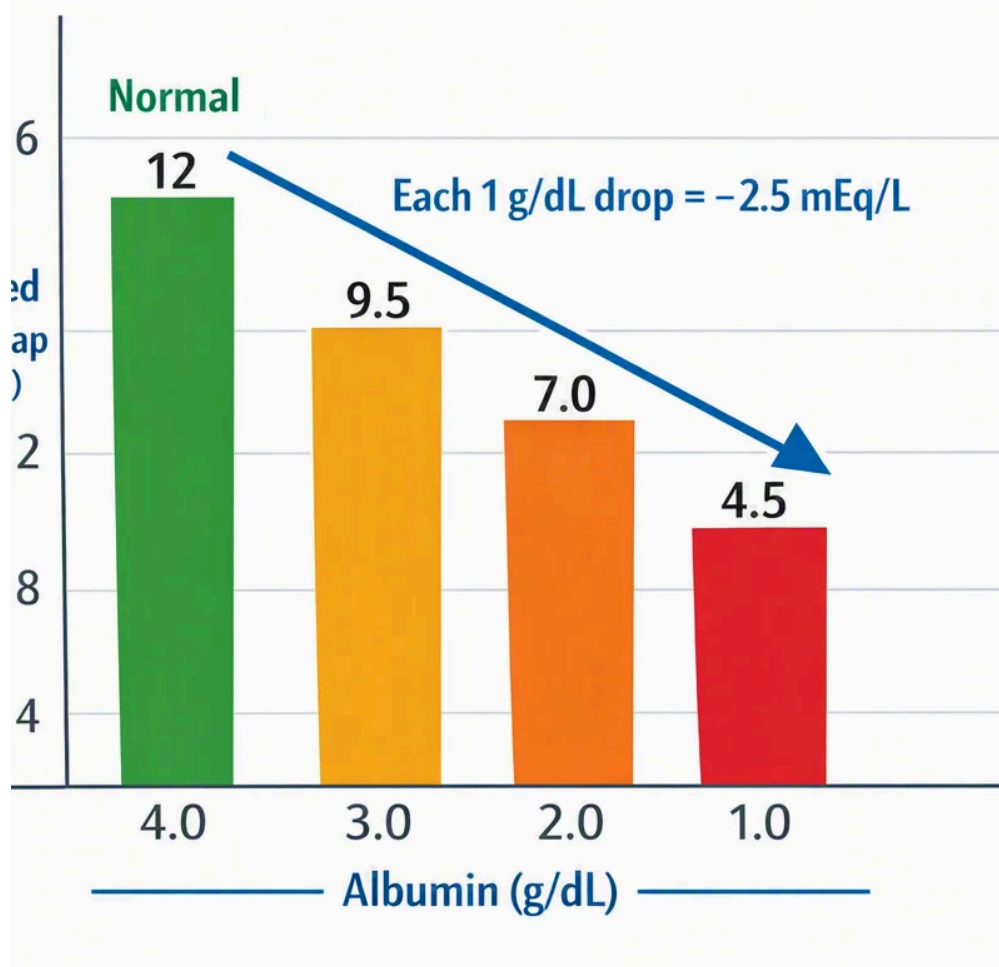

Mistake 4: Missing normal anion gap acidosis

Not necessarily every important acidosis causes a high value. A patient may have **normal anion gap acidosis**, also called **hyperchloremic acidosis**, where bicarbonate decreases but chloride increases to maintain electroneutrality. In this setting, the anion gap may persist within the expected limits even though the patient still has a significant acid-base problem.

Common causes include **diarrhea**, which causes bicarbonate loss from the gastrointestinal tract, and **renal tubular acidosis**, where the kidneys are unable to acidify urine appropriately. These conditions are often overlooked when clinicians focus only on high-gap disorders. That can delay treatment and lead to a false sense that the metabolic profile is not concerning.

In practice, the takeaway is clear: a normal value does not rule out acid-base pathology. If symptoms, history, or the electrolyte pattern suggest a problem, keep investigating. Looking at chloride trends, bicarbonate level, and the overall **metabolic panel** can help distinguish **hyperchloremic acidosis** from other disturbances.

Trap 5: Overlooking unmeasured cation elevations and toxins

The anion gap can also be altered by unexpected substances in the blood. Certain **unmeasured cations**, such as **lithium**, can lower or hide the gap by altering the balance of charged particles. In other cases, toxins create a high anion gap because they form acid or impair normal metabolism.

Toxic alcohols are a classic cause.
