

What an Anion Gap Calculator Assesses

An **anion gap** is a computed result that helps evaluate **electrolytes** and identify patterns of **metabolic acidosis**. An **Anion Gap Calculator** relies on routine laboratory values to estimate the difference between regularly measured ions and the unmeasured anions in the blood. 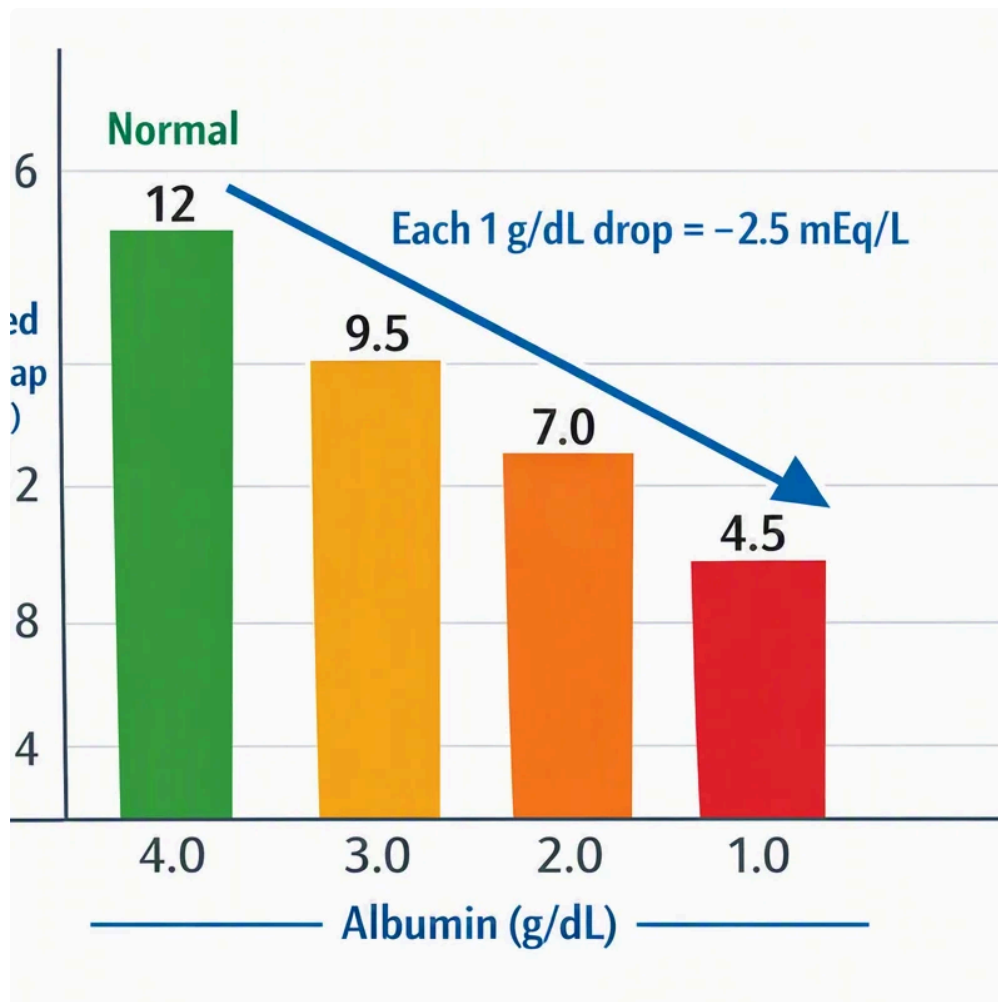
Anion gap = sodium - (chloride + bicarbonate)

Some calculators also add **potassium** in the equation:

Anion gap = (sodium + potassium) - (chloride + bicarbonate)

These two formulas estimate the difference between measured cations and measured anions. The formula without potassium is used more often because potassium is a smaller contributor to the gap in many routine

clinical settings. The calculator's goal is to identify an **anion deficit** or excess that may reflect unmeasured acids in the circulation.



To get the best results, use values from the same time period and the same lab system when possible. - **Chloride:** 100
- **Bicarbonate:** 16

Applying the usual formula:

$$\text{Anion gap} = 140 - (100 + 16) = 24$$

When potassium also be added and the level is 4.0, the formula becomes:

$$\text{Anion gap} = (140 + 4) - (100 + 16) = 28$$

Next add the venous blood gas values. When the venous pH is low and pCO₂ is also reduced, that supports a primary metabolic process with respiratory compensation. A bicarbonate of 16 and an elevated anion gap together suggest **high-gap metabolic acidosis**.

Afterward, consider albumin. When albumin is low, the raw number may underestimate the true gap.
