

If you ride and someone turned across your path in Atlanta, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes that is accurate. Frequently the driver simply did [experienced lawyer for truck accident](#) not see the motorcycle and turned across it.

The work is physical evidence, not story, since the story is doubted before it is told. The geometry of the turn do the arguing.
