

If you ride and were hit in Atlanta, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes it fits. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, since the story is doubted before it is told. Damage patterns do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
