

If you or your child were bitten in Atlanta, the rules may not be what you assume.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. Animal control files and witness memory both degrade, and the dog **lawyer for big rig accident** itself may be gone before anyone captures what it had done before.
