

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

When the app is off, the driver is just a driver, and their personal policy applies. When the app is on and they are waiting for a ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a small detail. It can decide whether the coverage available is modest or substantial, and the records that prove it sit with the rideshare company, not with you.

It matters [truck accident attorney](#) whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
