

What the Anion Gap Shows

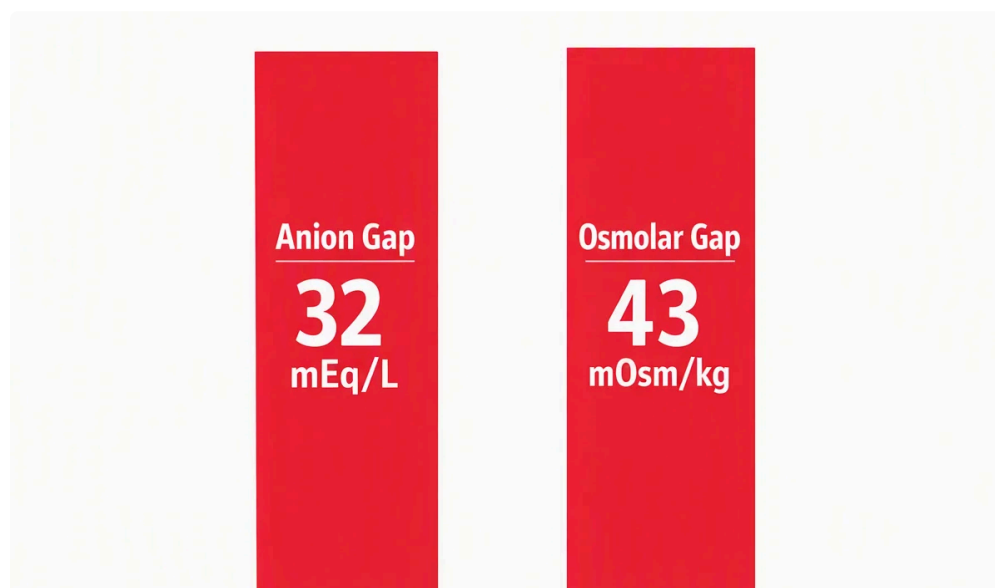
- **Lactic acidosis:** frequently connected with increased acid production or reduced clearance.
