

When someone is hurt in a bus collision in Georgia, there is a clock most people never hear about.

The general Georgia deadline for injury suits is two years. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, and it has to be in the right form and go to the right place.

A late notice can close a good claim before anyone looks at the merits.

Who owns the bus drives the analysis. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity analysis and what insurance responds.

Video is the other clock. Buses are heavily camerad, inside and out, and footage is frequently overwritten within weeks. Ask too late and there is nothing left to preserve.
