

When a dog attack leaves someone hurt in the Atlanta area, the legal standard surprises most people.

In some places an owner is liable automatically. Georgia is not one of them. Usually it comes down to whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether anyone contacted animal **Website link** control.

Records disappear quickly here. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
