

If a dog bit you in Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia is not one of them. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. Prior complaints and [local 18-wheeler accident lawyer](#) recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. How long do I have to file an injury claim in Georgia?

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
