

If a dog bit you in the Atlanta area, Georgia works differently than people expect.

In some places an owner is liable automatically. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, **car accident attorney** or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
