

How to Define the Anion Gap?

The **anion gap** is a computed value used to help read **electrolytes** in a **serum chemistry panel**. It is not measured directly; instead, it is determined from key blood chemistry numbers such as **sodium**, **chloride**, and **bicarbonate**. Clinicians apply it as a diagnostic clue when evaluating acid-base balance, especially when a metabolic disorder may be involved.

In plain language, the anion gap represents the difference between the major positively charged particles and the major negatively charged particles reported on routine labs. Because sodium is the main measured cation and chloride and bicarbonate are the main measured anions, shifts in these values can change the calculated result. That is why chloride is so important in clinical interpretation.

What a High Anion Gap Means for Chloride Values

A **increased anion gap** often indicates that additional acids are circulating in the blood. Often, chloride is not the leading cause of the elevated gap, but it can still help show the pattern.
