PARTIES

This PARENTING AGREEMENT ("Agreement"), dated June 1, 2020, is made and entered into by and between Anna B. Winkler ("Mother") currently residing at 1111 Herring Road, North Kingstown, Rhode Island, and Robert C. Winkler ("Father") currently residing at 1111 Herring Road, North Kingstown, Rhode Island. The Mother and Father are individually referred to as "Party" and collectively as "Parties".

WHEREAS, the Parties are the biological parents of the minor child, William Clayton, born February 26, 2012 ("Child");

WHEREAS, the Parties acknowledge that nurturing, providing, and safeguarding the Child's future development is a shared parental responsibility;

NOW, THEREFORE, in consideration of the mutual promises and covenants in this Agreement, of which the receipt and sufficiency are hereby acknowledged, the Parties further agree to the terms as follows:

TERMS AND CONDITIONS

TERM

This Agreement will be effective starting October 18, 2020, and will continue in full force until the Child reaches the age of majority (21).

SHARED RESIDENCY

The Child will live alternately with each Party every month. The Child shall live with the Mother the first month following the signing of this Agreement and alternate thereafter.

SHARED LEGAL CUSTODY

The Parties will make shared decisions regarding the health, medical, and dental care, education, legal issues, and other welfare and development programs of the Child.

SHARED PARENTING AGREEMENT

RECORD AND INFORMATION

Each Party shall have equal access to the medical, educational, and legal records and information of the Child.

COMMUNICATION

Each Party shall allow the Child to communicate with the other Party within a reasonable duration of a reasonable time. The Party with custody of the Child shall immediately notify the other Party in the event of an emergency concerning the health and welfare of the Child.

AMENDMENTS

Any modification, amendment, or supplement to this Agreement shall be done in a written instrument mutually agreed and signed by both Parties.

GOVERNING LAW

The terms in this Agreement shall be governed by and construed under the laws of the State of Georgia.
