

If you were hurt on a bus around Atlanta, the timeline is not the usual one.

The general Georgia deadline for injury suits is two years. Where a government entity owns the bus, written notice may be due in months rather than years, and it has to be in the right form and go to the right place.

Missing that notice can end an otherwise strong case before it starts.

Ownership determines almost everything here. Injuries on a public transit bus, a school bus, a private charter [18-wheeler collision attorney](#) and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity questions and what insurance responds.

There is a second deadline nobody announces. Buses are heavily camcared, inside and out, and footage is frequently overwritten within weeks. Ask too late and there is nothing left to preserve.
