

If you were riding and someone turned across your path in Atlanta, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was weaving through traffic, or took a risk a car driver would not.

Occasionally that is true. Frequently the driver simply did not see the motorcycle and turned across it.

Reconstruction matters more here than testimony, since the story is doubted before it is told. Scene measurements carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, [truck accident injury lawyer](#) so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
