

If you ride and were hit around Atlanta, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or took a risk a car driver would not.

Occasionally that is true. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, because narrative starts at a disadvantage. Damage patterns do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so the same <https://zandermqlb390.yousher.com/job-site-electrical-lawsuits-in-north-georgia-who-is-actually-responsible> impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
