

When a rider is hurt and a driver did not see you in Georgia, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Scene measurements do the arguing.
