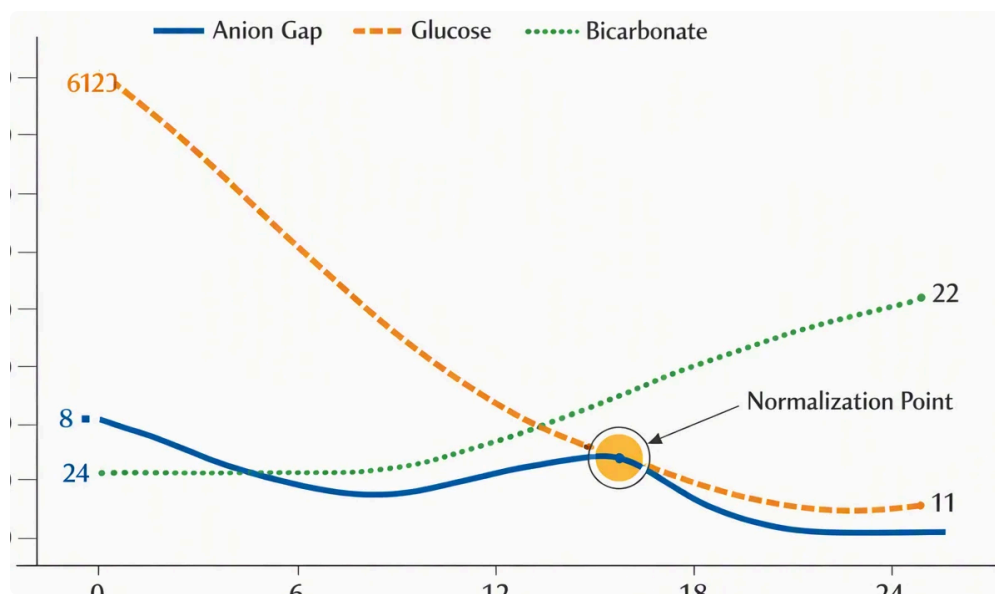
Is an Anion Gap of 20 High?
