

If a dog bit you around Atlanta, <https://www.wordspringer.com/s/jkBYkuTmtw9clwg-03DxR> the rules may not be what you assume.

In some places an owner is liable automatically. Georgia is not one of them. The question is normally whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. Prior complaints and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
